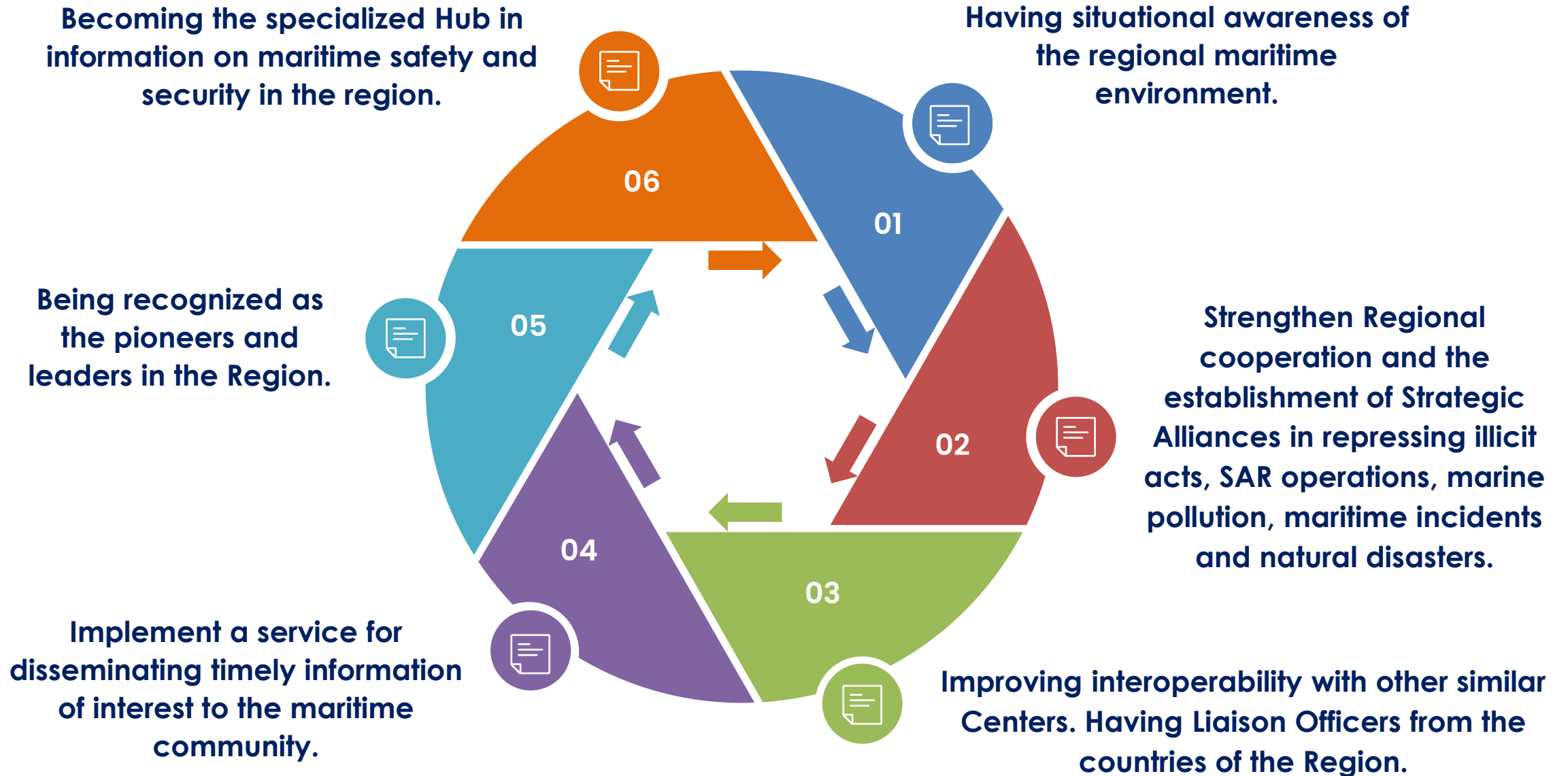
Creation of IFC Peru

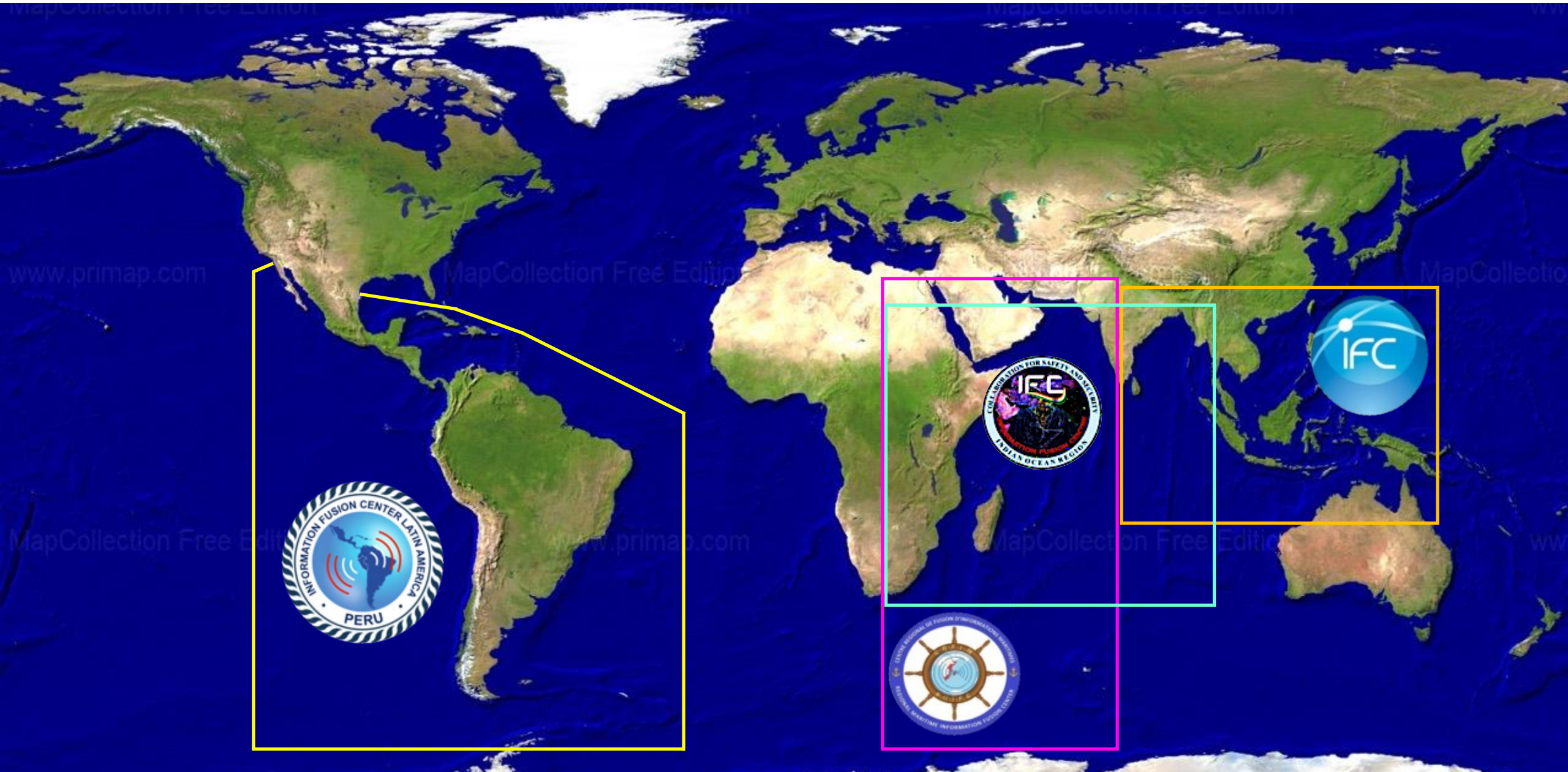


Duties of IFC Peru

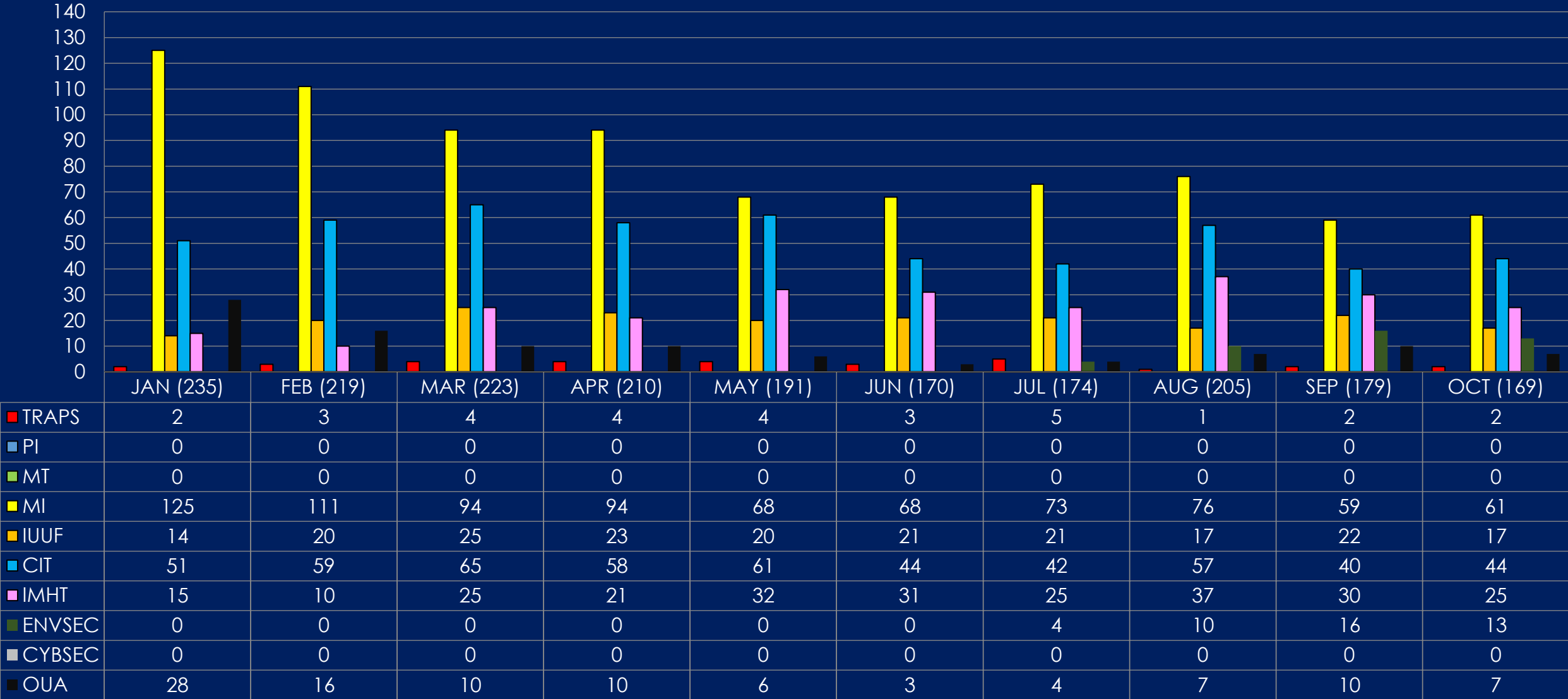

- During this year, IFC Peru has reported a total of 1,975 maritime incidents, which would represent an increase in the number of reports of 25% compared to the year 2021.
- The MI and CIT categories are the ones with the highest incidence.
- In IFC Peru's area of interest, there have been no incidents in the MT and CYBSEC categories.

Number of Incidents presented in 2022 (January – October)



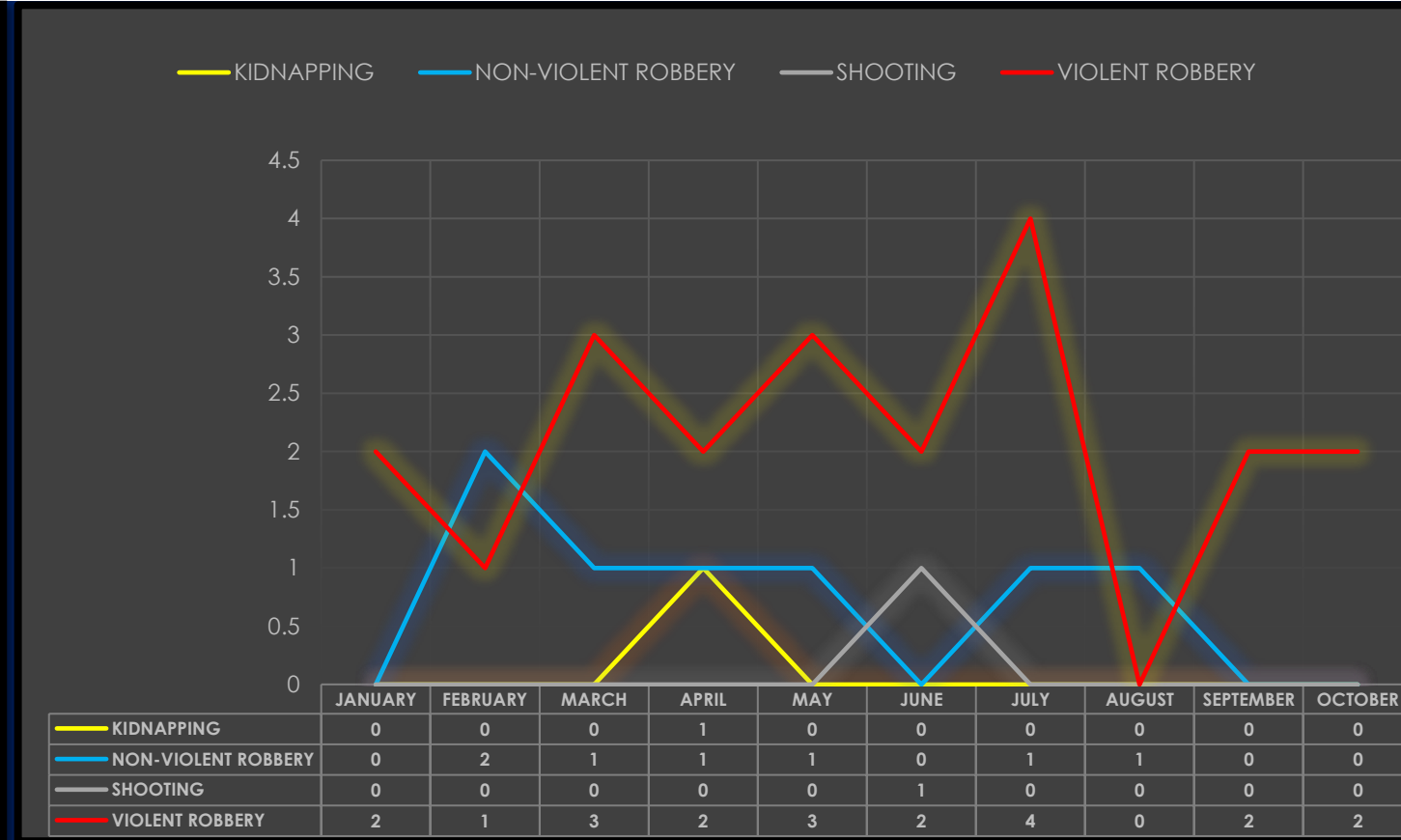
Incidents in the area of interest of the IFC Peru

Category "Maritime Incidents" records a total of 829 cases, being the category with the highest number of cases during this year, having an average of 83 incidents per month, with January being the period with the highest record, counting a total of 125 cases.

Category "Contraband and Illicit Trafficking" registers a total of 520 cases, being second category in number of cases, its highest record was detected in the month of March with 65 cases.



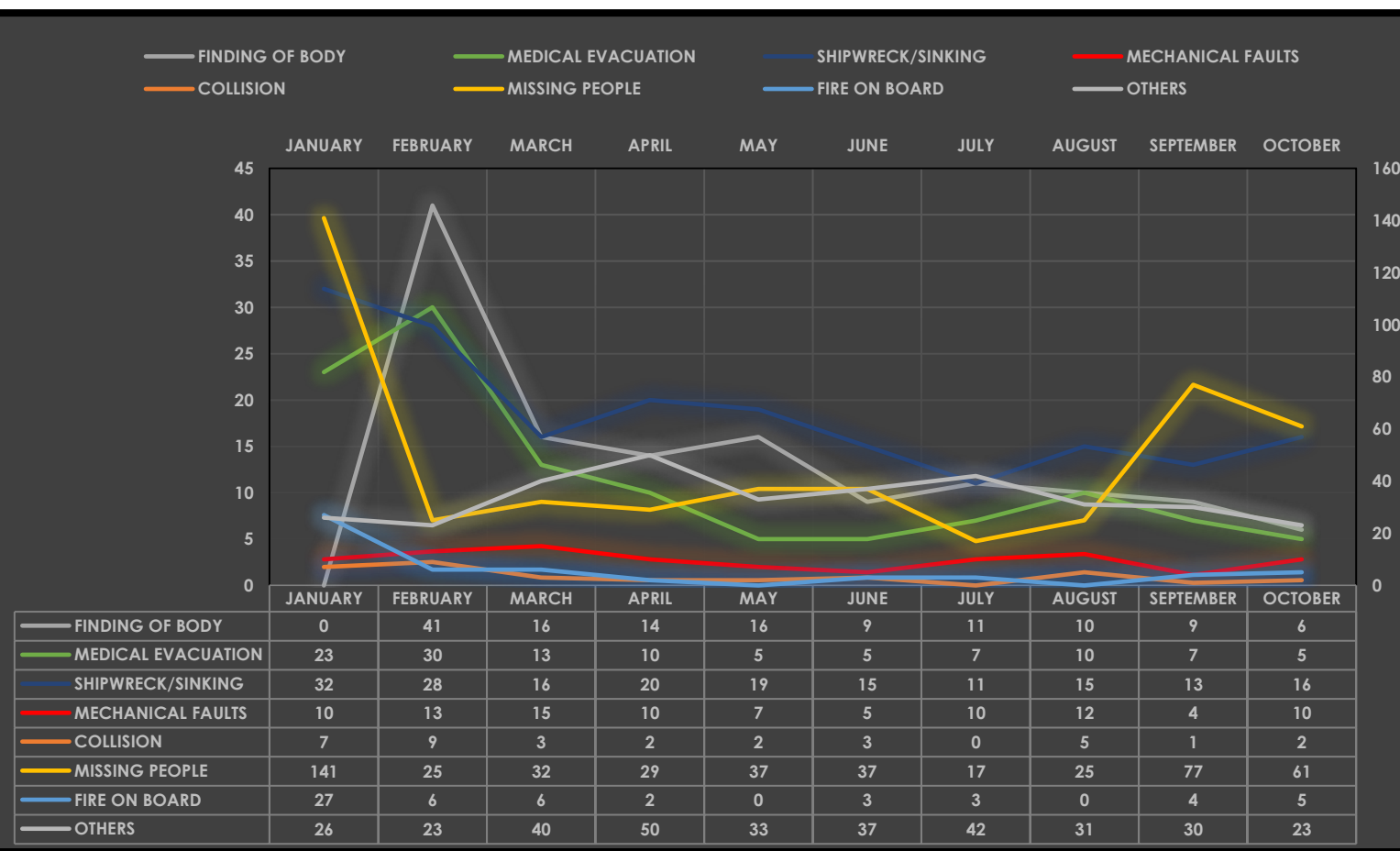
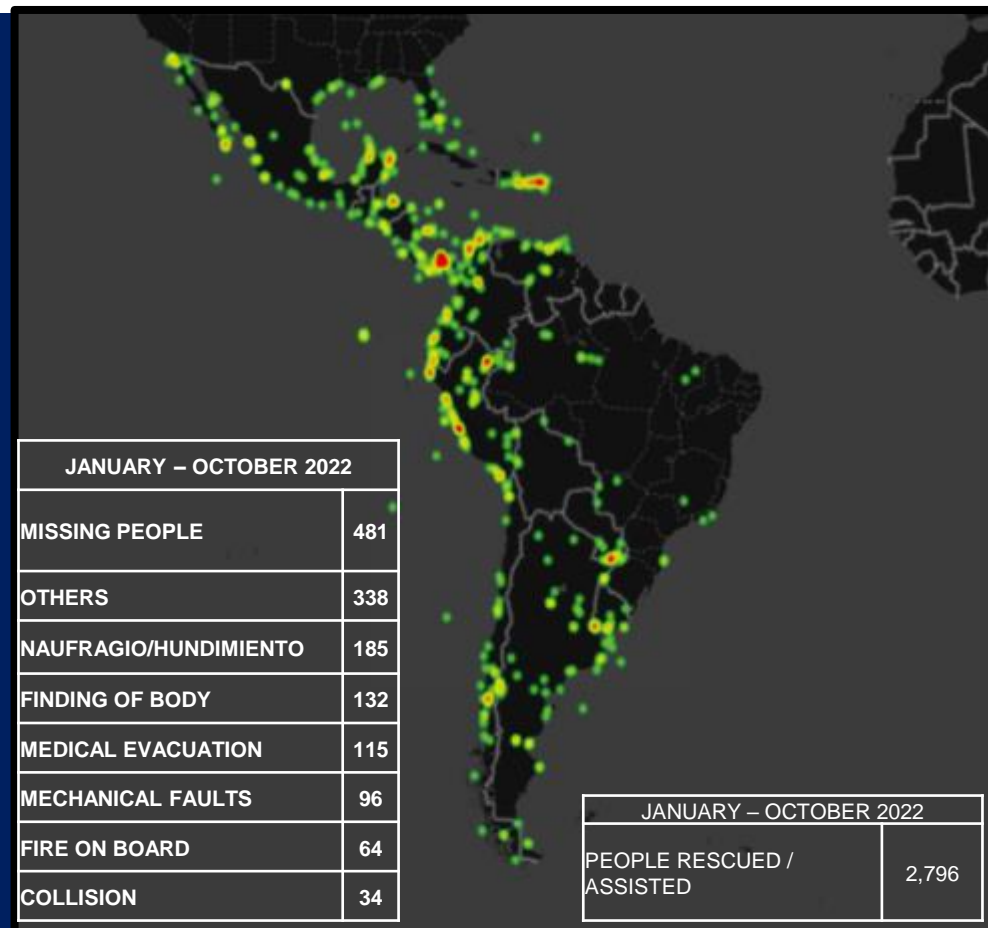
Theft, Armed Robbery & Piracy at Sea (TRAPS)



Central America: Mexico, Puerto Rico, and Haiti had the highest concentration of violent robbery cases.

South America: Ecuador, Peru, Colombia and Venezuela are the countries that presented cases of violent and non-violent robbery, with one kidnapping occurring in the town of Chocó-Colombia.

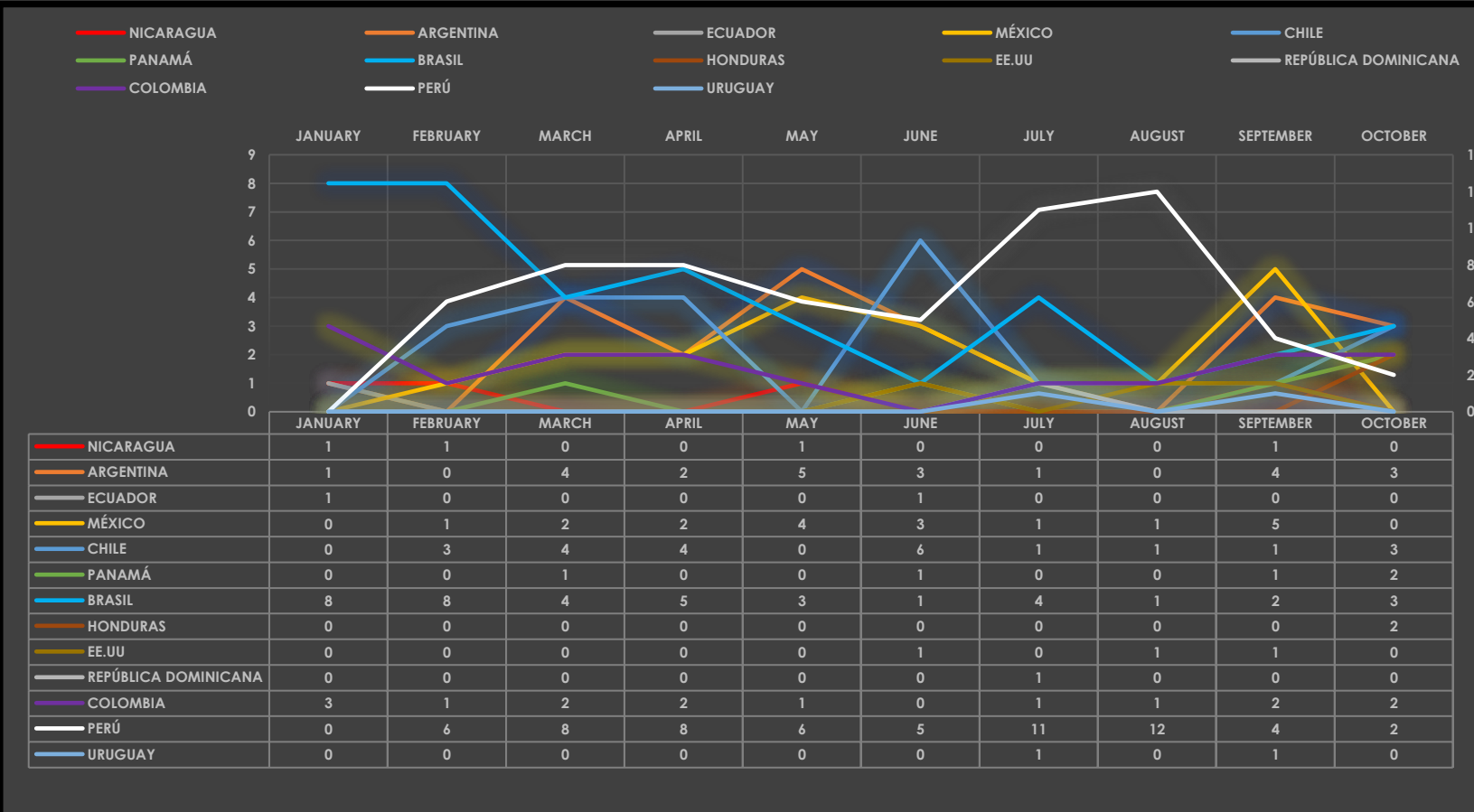
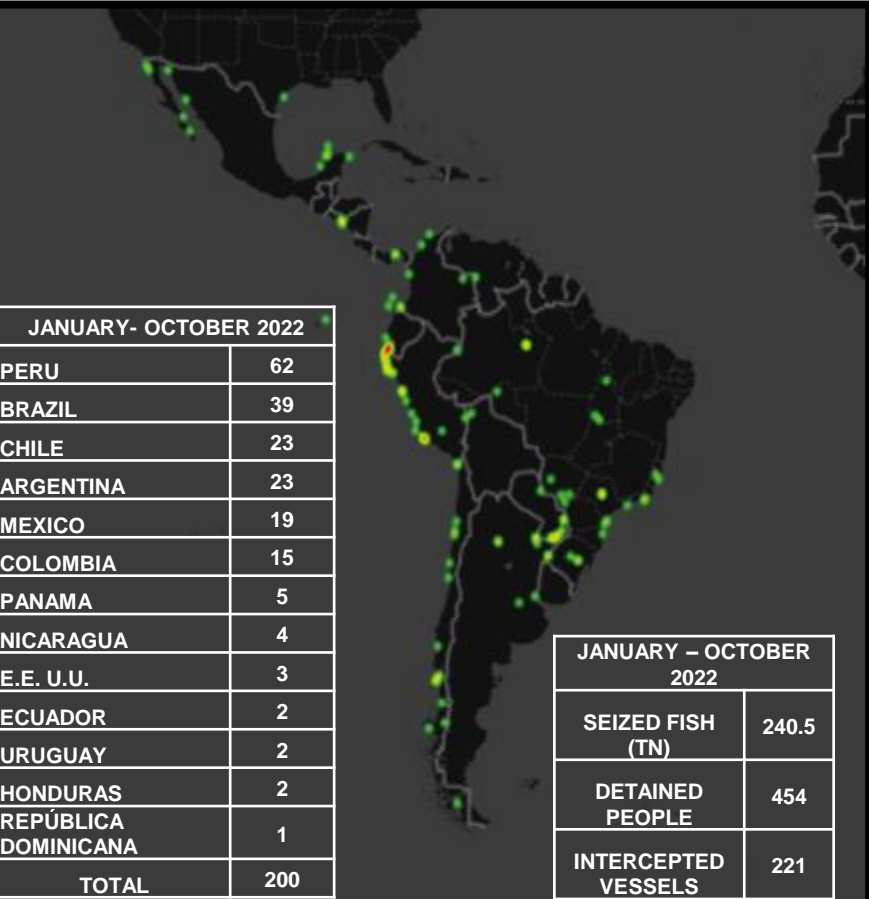
Maritime Incidents (MI)



In the category of Maritime Incidents, the shipwreck and sinking of vessels represents the incidence with the most constant frequency.

Regarding the number of missing persons, this report would be having an increase of 40% compared to the year 2021.

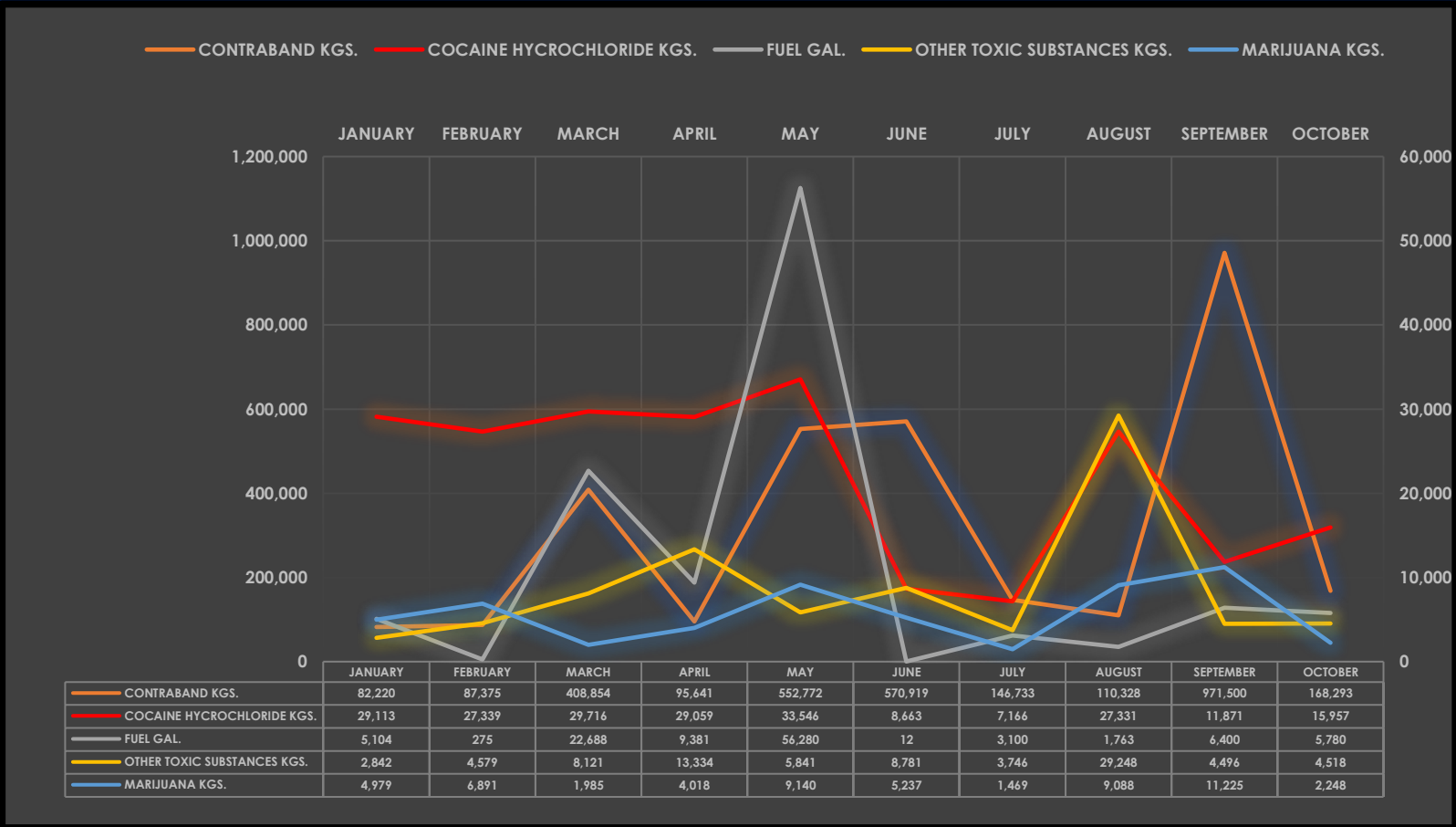
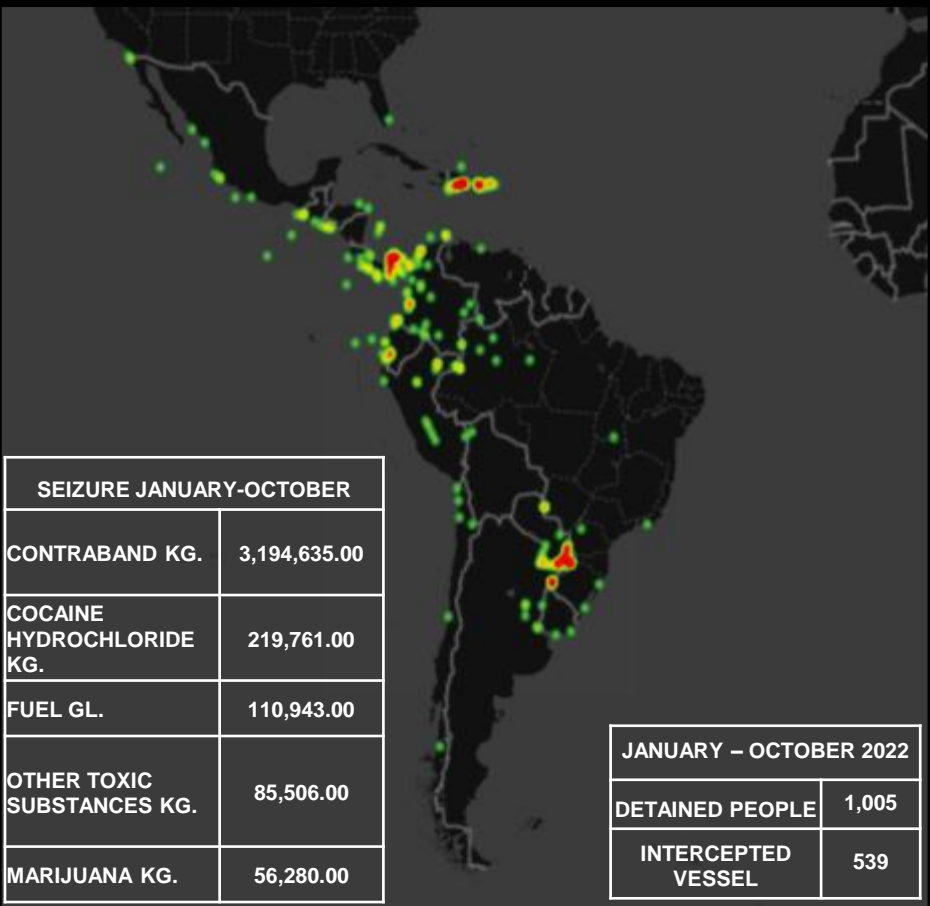
Illegal, Unreported and Unregulated Fishing (IUUF)



According to what is observed in the heat maps, the borders of Peru with Ecuador, and Argentina, Uruguay and Brazil concentrate the largest number of reports referring to this Incident.

Likewise, regarding the amount of seized fishing, this number would have suffered an increase of 10% in relation to the year 2021.

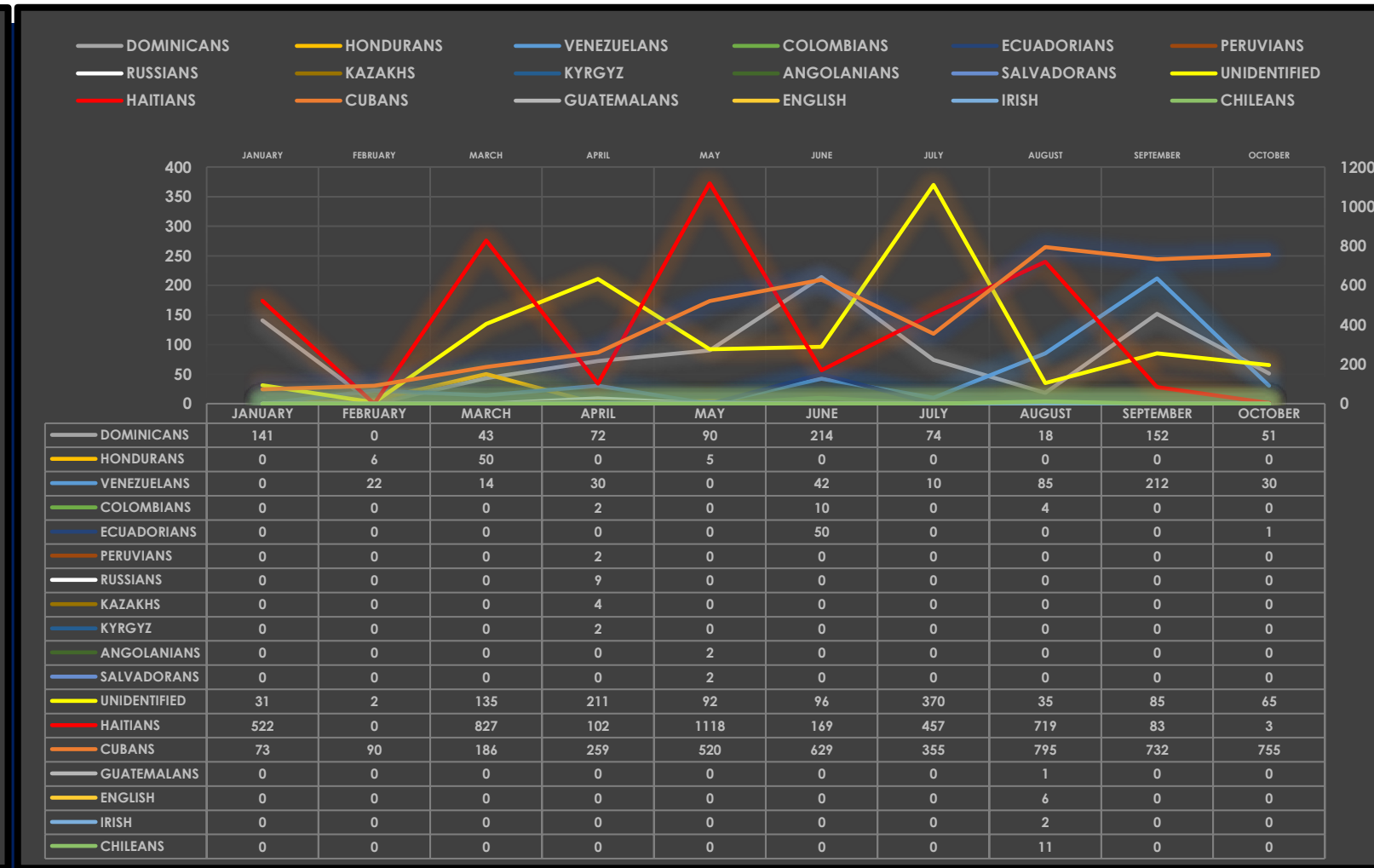
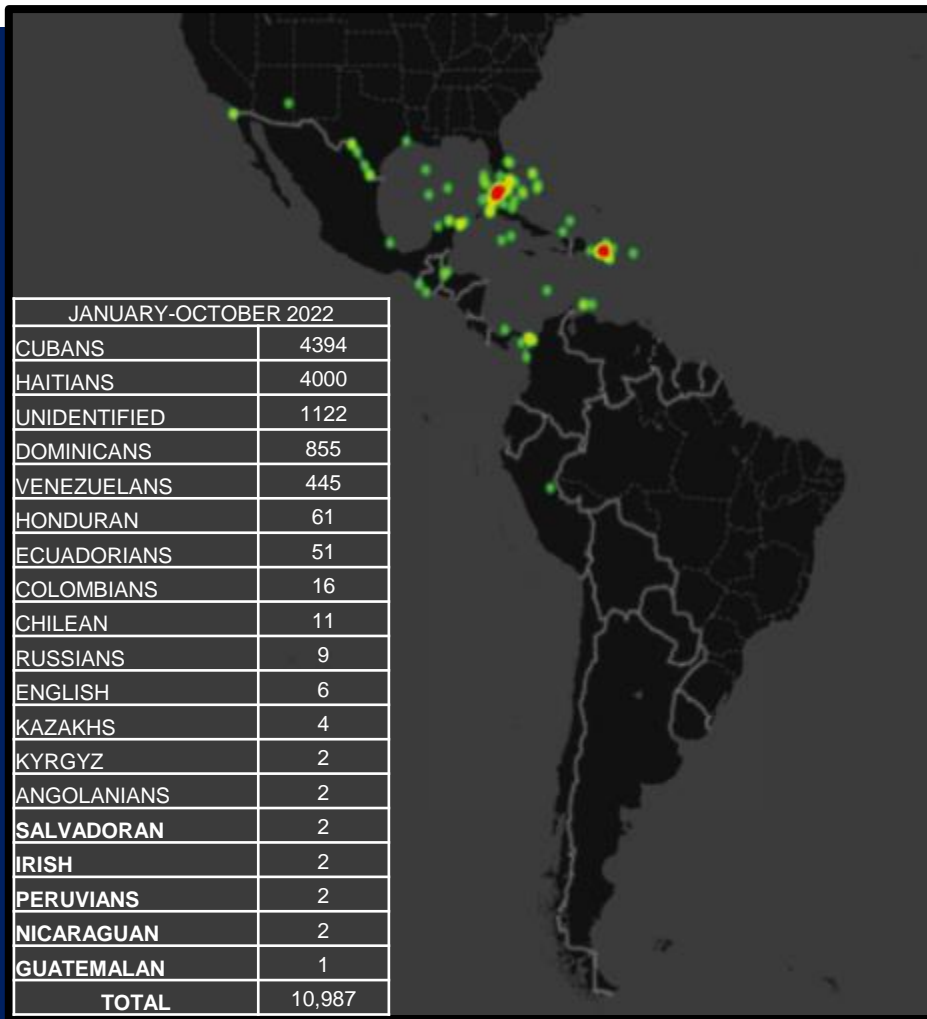
Contraband & Illegal Trafficking (CIT)



In the area of Central America, the largest number of incidents in this report is concentrated in the Caribbean, followed by the border area of Brazil with Argentina and Uruguay.

In relation to the number of annual seizures, referring to each type of substance, the average amounts are maintained, only in the case of fuel trafficking this amount would have decreased by 50%.

Irregular Migration and Human Trafficking (IMHT)



Central America: In the first semester, the largest mobilization of migrants occurred from Cuba and Haiti to the US, followed by the mobilization of Dominican migrants to Puerto Rico.
